Applications for tenders must be submitted enclosed in plain sealed envelopes marked with the tender name and reference number and deposited in the tender box located on the ground floor, Tana Water Works Development Agency, P.O. Box 1292 10100 NYERI, Maji House, Baden Powell Road, addressed to the Chief Executive Officer, so as to be received on or before Wednesday, 19th May, 2021 at 10.00am,
- VII. Candidates who wish to attend and witness the receiving and subsequent opening of the bids (after 7 days) are hereby requested to make formal application. Only ten (10) representatives from the interested bidders shall witness the receiving and sealing of the documents;
- VIII. The Bids upon receipt SHALL be sealed in the presence of the interested bidders who shall attend. They will then be treated and quarantined for seven (7) days to be opened **on Thursday 27th May 2021** in the presence of the interested bidders who had witnessed the sealing;
