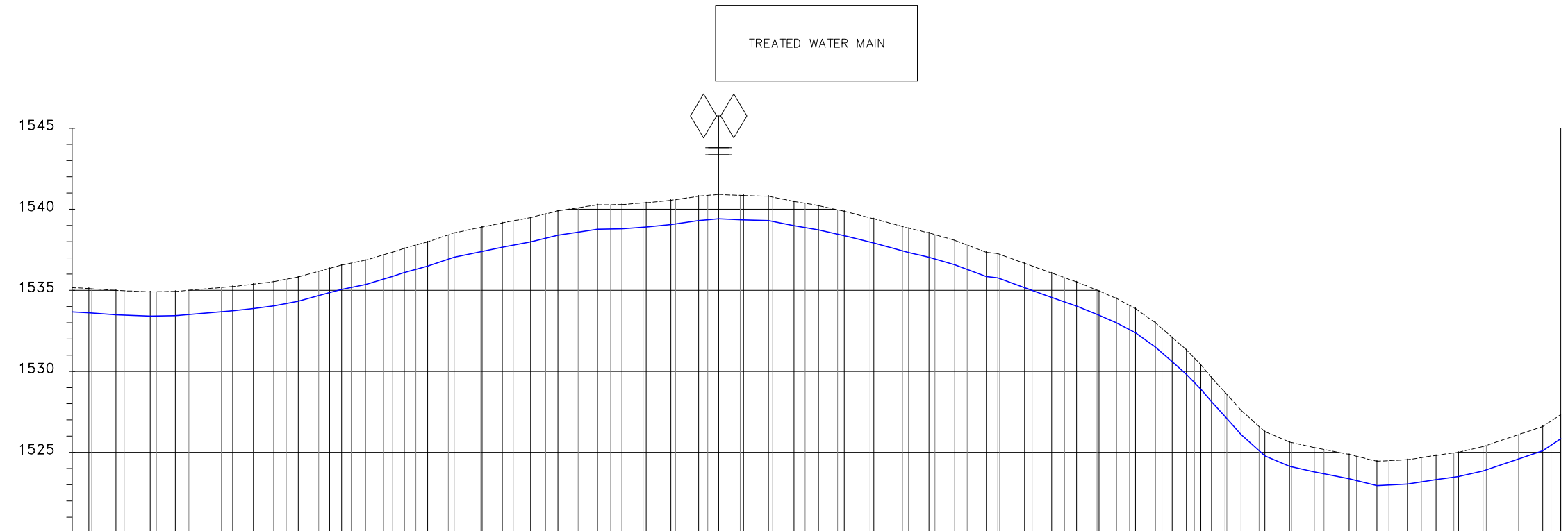


- NOTES**


