The objective of this consultancy is to engage a consulting firm to undertake Design Review, Preparation of the Tender Documents, RAP and Supervision of Construction works for: **Runyenjes Water Supply Project**.

- The Scope of works for the project entails;
- 1) Construction of 2No. intakes.
 - 2) Laying of 19km raw water mains.
 - 3) Construction of a 15,000m³/day conventional water treatment plant.
 - 4) Laying of 44 km treated water mains.
 - 5) Laying of 62 km last mile connectivity lines.
 - 6) Construction of 10No. Storage tanks ranging from 225m³-1,000m³.
 - 7) Construction of 2No. Break Pressure Tanks..
 - 8) 5000 New Customer connections.
 - 9) Water Service Providers support.
